Report: Social Planner, Community Development,
April 22, 2003

Mr. L. Orr, Social Planner, provided introductory comments regarding the presentation of the Final Report from the Professional Environmental Recreation Consultants Ltd. and Wilson & June Consultants who conducted the Harry Jerome Leisure Needs and Space Assessment. Mr. Orr introduced Mr. Bill Webster from Professional Environmental Recreation Consultants Ltd. who presented the Final Report accompanied by Heather Fleming and Nancy McMillan, North Vancouver Recreation Commission who were members of the Project Steering Committee.

The PowerPoint presentation of the Final Report on the Harry Jerome Leisure Needs and Space Assessment included the following conclusions and priorities:

Conclusions:

- Initiate site planning and design for the replacement of facilities at the Harry Jerome Complex;
- Give priority to the inclusion of an entrance lobby/reception area, arena, aquatic centre, fitness space, leased space for revenue generation, a gymnasium/gymnastics facility, space for seniors and youth, multi-purpose space and improved outdoor facilities;
- Further study be undertaken regarding the need for an indoor tennis centre, and indoor bowls facility, and outdoor requirements at the Mickey McDougal site.

Priorities:

- Consolidation of uses under one roof as much as possible;
- Retention of the courtyard and park site at 23rd and Lonsdale;
- A comfortable entrance lobby/reception area;
- A regulation sized ice arena, with 1,200 to 1,500 seats;
- An 8 lane 25 metre aquatic centre, with a leisure pool;
- A comprehensive fitness centre;
- Leased space for revenue generation;
- A gymnasium complex, with 2 full size gyms, the gymnastics centre and an indoor running track;
- Dedicated space for seniors and youth;
- Flexible multi-purpose meeting and activity space;
- A red-developed outdoor sports complex at the Mickey McDougal site.

Mr. Webster, Mr. Orr and Ms. Fleming then responded to questions from members of Council.

(e) Secondary Suites – File: 3365-05-02

Councillor Keating advised that he will present the following motion at the next regular meeting of Council:

WHEREAS secondary suites constitute one of the most important forms of affordable housing for both owners and renters in the City of North Vancouver;

AND WHEREAS only 120 secondary suites are currently approved under the City's existing regulations, while approximately 1500 remain unapproved and forty are closed annually because of the prohibitive costs of bringing them into strict compliance with the B.C. Building Code;

AND WHEREAS other jurisdictions have introduced suite legalization guidelines that deviate from the Building Code (while still maintaining its health and safety provisions) to allow for the legalization of secondary suites in housing stock similar to that of the City;

THEREFORE BE IT RESOLVED THAT staff be directed to bring forward recommendations on ways to facilitate the affordable legalization of secondary suites.
