Her Worship, Mayor Barbara A. Sharp, delivered the following address:

“Members of Council, ladies and gentlemen. It is my privilege this evening to present to you, our citizens, my Annual Address for 2004. As we have just passed the mid way point of this Council’s term of office it is also an appropriate time to review the first half of the work done by Council and staff and to look ahead to the plans leading into 2005.

In part I will be addressing what was promised in my December 2002 inaugural speech and reviewing what changes have been implemented. I also wish to share with you the successes of 2003 and the ongoing developments for 2004.

First I would like to recognize an honour bestowed upon a former Councillor. Recently, John Braithwaite, was inaugurated into the Federation of Canadian Municipalities Roll of Honour for his dedication to the FCM and the many years he spent on committees dealing with issues of national importance to all communities such as racism. John has over 23 years of service and his commitment to representing the FCM in his own passionate, determined style also served this City so well. Congratulations John, thank you on behalf of Council and all our citizens.

One re-occurring theme you will note in this address is the overlap of departments in the services and programs that the City offers to residents. Enhancements in service to the public usually come with the successful cooperation of several departments.

Also throughout this entire process I look to the future, and the exciting challenges of progress. A vital link in facing those challenges is residents input which assists Council in our decision-making, and will in turn affect the future development of our community and the environment in which our community will live in. As such another re-occurring theme will be opportunities to receive input on various projects the City is evaluating or developing.

At times, it takes courage, in making these decisions, no matter how sincere and sound these decisions may be, there may be those who challenge these efforts. Whether on issues of density, traffic flow, development in Lower Lonsdale, Marine Drive or the Library re-development I truly believe members of our community are genuinely interested in our City and its future. Through their continued efforts and us, their representatives, working together – so much is possible.

Innovative changes were promised in the City Clerk’s department and many have now been completed or are well underway. For example providing video transmission of Council meetings online. This is available live on our website during every Council meeting and since January of this year, previous meetings are also available on our website for public viewing.

An electronic records document management information system is being implemented, providing e-access to all City documents.

As well, the City continues to embrace technology for the benefits of its citizens with the intent to enhance ease of access to information. The on-line agenda is also being enhanced such that Open Council reports will soon be available simply by clicking the report title in the online agenda, this should be implemented on the website by this September.

The City has been the host in the implementation of the Bylaw Forum-North Shore Bylaw Notice Dispute Adjudication Registry. This innovative new program will streamline the process for those who receive a bylaw infraction notice anywhere on the North Shore. In conjunction with this development the City Clerk's department has increased enforcement for Skateboard regulations, helmet bylaws, car alarms, and Parks bylaws.

Our Information Technology department has been working proactively with all other departments to implement new software programs, enhance hardware services and facilitate enhanced customer service. As I just mentioned with regard to the City Clerk's example of enhanced website functionality for Council meetings and Agendas.

Notable highlights of this past year include the complete redevelopment of the City's web site as part of a full communications plan using new update tools and software that better supports other browsers in cooperation with our Communications Officer.

Information Technology staff are also busy preparing the new John Braithwaite Community Centre for phone and communication links to City systems as we approach the imminent opening of the Centre.

2003 saw several successes by the RecCommission.

The Harry Jerome Complex Needs Assessment report was presented in 2003. This community survey addressed current and future recreation needs in the City. Planning is currently underway for the re-development of the Harry Jerome Centre and we are all looking anxiously forward to the major changes coming for the site.

The Terms of Reference for Centennial Theatre governance was completed. An Interim Governance Committee has been formed with Commissioners Barbara Perrault and Elizabeth McLaren involved. The committee is now moving forward with plans to partner with a not for profit society.

We have seen an increase in Fitness memberships to over 11,600 in 2003 up from 10,500 or approximately 10% over 2002

2003 also saw the Launch of the Active for Life campaign (which is currently underway for 2004) which promotes the health benefits of an active lifestyle. The recCommission facilitated the formation of the Active for Life North Shore Alliance with the West Vancouver Parks and Recreation, Vancouver Coastal Health, North & West Vancouver School Boards, the North Shore Credit Union and North Shore News.

The North Vancouver Recreation Commission (NVRC) is developing **Active Vision 2015 – a recreation plan for all North Vancouver**. This 10-year plan will be completed by the end of 2004 and will provide a broad vision for the delivery and management of recreation services and facilities in North Vancouver for the years 2005 – 2015.

The Harry Jerome recCentre was voted the **Favourite Community Fitness Facility** on the North Shore in the annual North Shore News Readers Choice Awards.

The new John Braithwaite Community Centre is scheduled to open this summer. The City of North Vancouver, North Shore Neighbourhood House, the North Vancouver Recreation Commission and the Citizen Board are working together to support the centre's success in delivering quality recreation and community services.

We are excited about the development of recreation and community services for the Lower Lonsdale community. This area is poised for major growth and we look forward to meeting our neighbours and learning more from our community about their needs and expectations.

Our community is fortunate to enjoy such a broad range of recreation, sports, arts, culture and fitness opportunities.

Throughout the City, we continue to focus on enhancing the quality of life for residents and visitors through cultural activities including the public art program, community events and outdoor concerts in our cultural venues. Implementing the Cultural Plan will assist in directing the cultural community towards new and exciting cultural initiatives.

The Public Art Program continues to provide our community with a lasting, creative legacy throughout the City. With public art integrated throughout the City and creatively woven into our existing infrastructure, we can enjoy and take pride in the artistic expressions produced by renowned artists, to the unique works produced by our youth, we can enjoy the enormous creativity this community offers within our day to day travels.

Our programs for youth are expanding. Providing youth with spaces to meet, connect and spend time together is a key priority. The new skate park had a large successful opening in May and will continue to be a highlight for youth long into the future.

Staff in the Permits and Inspections Division of the Community Development Department have completed a complete rewrite of the existing Building Bylaw. This new bylaw, in conjunction with anticipated changes in the Local Government Act has raised the standard of construction in the City to better serve the taxpayers by helping to protect the community from issues like the leaky-condo disaster.

The culmination of a decade of planning in Lower Lonsdale is seeing the beginning of construction activity in earnest taking place and will continue over the next five years.

The Lower Lonsdale Planning Office is open at 131 East Second Street and a public consultation process is underway to develop options for Council for further development in the area.

Open houses are scheduled for Wednesday July 7th and Thursday July 8th, Public drop-in is also encouraged to gain as much feedback as possible about community needs and wishes.

The City has an Official Community Plan that guides many of the decisions of Council. Thoughtfully put together by our Community Development staff with input from the public and Council, the OCP is based on the concept of sustainability. Simply put, our Plan is a guide to help the City and its residents live more within our means from an environmental, economic and social perspective. We must try harder to create a better City not just for us but also for the generations that come after us. A recent review of the City's initiatives in conjunction with our OCP and the Livable Region Strategic Plan was offered by Ken Cameron, Manager of Planning and Policy for the Greater Vancouver Regional District. I quote .."it is increasingly clear you are doing something better here." I know that I,... and I am certain Council... was pleased to hear the positive report.

Over the past three years and for most of the last ten, the City has been the centre of North Shore activity. With growth and new migration to the North Shore comes many new challenges and opportunities. We will continue to work hard to make the City a welcoming place and a place that provides for all of its residents. The City is in the construction phase of a permanent homeless shelter to house our most vulnerable residents and our Community Planners and our North Shore Task Force continue to develop strategies for substance abuse and other social issues to respond to the needs of North Shore residents on the North Shore.

Our commitment to district energy continues, as the Lonsdale Energy Corporation was established and the Federation of Canadian Municipalities contributed \$4M in grants and loans to the City for this initiative. In partnership with Terasen, the City will be offering environmentally friendly and cost effective energy for our incoming Lower Lonsdale and Shipyard residents. The City Council and staff's leadership and foresight in establishing our own energy utility has served as a community based model for communities across the province and the country who are attempting to find ways of establishing long term cost efficient, environmentally sound and locally controlled energy services. Recognition is already flowing our way with the Canadian Association of Municipal Administrators prestigious **Willis Award for Innovation**. In the category of 'Municipalities over 20,000', the Lonsdale Energy Corporation's "district heating utility" project was recognized for its "exceptional innovation and initiative, as well as outstanding development and implementation". For 2004 and 2005 we will be installing a district heating piping network throughout Lower Lonsdale.

In the area of development the City is rapidly moving forward with further redevelopment of City lands and waterfront lands that will re-establish our community's connection with our waterfront heritage. Residents will be able to enjoy enhanced streetscapes, public plazas and waterfront amenities by the end of this term of Council. Quality of life and desirability of the City as a place for living, working and recreation is being elevated during this term of Council.

The future transportation program will continue to support sustainability principles with the focus on pedestrian, cyclists and transit improvements, improving road safety and renewing existing infrastructure such as traffic signals and signs. The program has continued with several activities such as the traffic-calming program, with traffic circles (with flower beds) constructed in the Ridgeway, Marine and Hamilton neighbourhoods, improvement of the Lower Level bike route, implementation of the Lonsdale Transit Priority and development of the Transportation Plan and Safer City Roads Plan. It will also include finalization of plans and partial implementation of improvements for Esplanade and Grand Boulevard corridors and installation of accessible pedestrian signals to help the visually impaired.

Future work will concentrate on finding ways to accommodate an anticipated increase in the number of vehicles on the roadway without creating a need for more road space, ultimately, the City is working towards developing an integrated multi-model transportation system that accommodates a variety of uses, namely pedestrians, cyclists, buses, shuttles, trucks and cars.

As well, the City continues to concentrate on arterial road rehabilitation.

The City has continued making great strides in moving environmental initiatives forward. In 2000, Council endorsed the implementation of the City's Environmental Protection Program. The EPP is based around a five-year Action Plan that includes the development of Environmental Stewardship Bylaws in 2003, to interact with other GVRD member municipalities. An example is the excellent stewardship programs like the Mahon Park Ivy Pulls in which volunteers and staff come together for parks rehabilitation.

The primary focus of the 2003 Environmental Protection Program work plan was the development and implementation of a suite of Environmental Stewardship Bylaws to help ensure the protection of the City's natural resources. These regulations not only form an integral component of the Environmental Protection Program, but also support the goal of creating a 'sustainable community' as stated in the City's new Official Community Plan.

In terms of awards, recognition has been given by the Canadian Society of Landscape Architects for St. Andrew's Park. The City was awarded the Society's **Regional Honour Design award** for leading the way in integrating sustainable park renewal with the social and recreational aspects of a neighbourhood park. We were also honoured by the North Shore News Readers Choice Award for Best Running Trail for Mosquito Creek Trail.

The City's Parks and Greenways Strategic Plan is another exciting initiative which spawned an implementation plan. Integration of land use, transportation and environmental systems and social interaction is the essence of the City's proposed Greenway system. The Parks and Greenways Plan will take up to twenty years to implement, however, the focus of the next few years will be completing the Green Necklace, the historic loop of green space that was laid out in the 1906 town plan for the City of North Vancouver.

Rehabilitation of the trail system has begun and will continue in an effort to save badly eroded stream banks and trails, replace access stairs and enhance trailheads and signage. Stewardship activities will be on-going throughout 2004 and beyond.

Through its participation with the Federation of Canadian Municipalities' Partners for Climate Protection Program the City of North Vancouver has been the regional leader in municipal efforts to reduce greenhouse gas emissions, one of the principle causes of global warming. The City of North Vancouver became only the 2nd municipality in BC to complete Milestone 2 of the program and establish its greenhouse gas reduction targets. Most recently, the City has been awarded a \$20,000 Green Municipal fund grant in order to complete Milestone 3, our greenhouse gas Reduction Action Plan.

By promoting green building design, energy efficiency, investigating opportunities for alternative fuels used in vehicles in the municipal fleet, planning for a more sustainable community, the City's goal is to lead by example, demonstrating that cost efficient methods of reducing greenhouse gas emissions are feasible.

The Library redevelopment project continues to make progress. Earlier this year a design team was hired to take the project to the next level. Shortly Council will make final decisions regarding location of the new Library and other issues to deliver on the broader objectives of this high profile and high priority project. The new library will be a community meeting place that promotes popular materials, life long learning and literacy. It will embrace new technologies that will increase effectiveness as well as increasing access to information and provide for tools to increase computer literacy.

We truly do need to work together. Gone are the days where our community can remain an island or act as an individual silo for our own community only. We must strive to work together with other groups in the community, both the Federal and Provincial governments, and international organizations such as the International Council for Local Environmental Initiatives (ICLEI), as well as each other. Only then can we hopefully maintain and achieve an even better and kinder world and society we all cherish. Money and security are matters that we all must expend our efforts to ensure so we can provide both the necessary security for our citizens as well as enough dollars to ensure we have an inclusive society.

Long term global relationships such as our 35 year cultural sister city exchange with Chiba, Japan, do wonders to bring the world closer and exchange valuable personal and economic relationships that will hopefully ensure all of our futures.

In the area of public safety, together, with the RCMP, we are committed to providing a safe community. In the City of North Vancouver we enjoy living in one of the safest communities in the Lower Mainland. Council looks forward to the continued support of our police force to maintain and even improve on this desirable situation.

In regards to Fire and Rescue, I am pleased to update that the New Automatic External Defibrillators are in service and serving our citizens well during incidents of cardiac arrest.

Our new pumper truck has been ordered and is in town now having the final details completed. It should be in service at the end of September to replace the old Engine 12.

The KEY message for Fire and Rescue I need to provide to residents is in regard to the serious dry conditions that are affecting the region and the hope that all citizens will do their part when using the forested areas to ensure a safe and uneventful forest fire season. North Vancouver City Fire and Rescue crews are out in the City right now visiting homes that have an urban/wildland interface connection to assist homeowners and advise on how to help reduce the instance of fires in the forested areas adjoining their homes. Please do your part.

On the financial front, the City has a long, solid reputation of strong fiscal management. My goal, which is shared by Council, is to maintain this excellent reputation. To help accomplish this goal, an improved long term financial planning process has been initiated which will see real public involvement in the budget process with a view to focusing on strategic issues. The development projects mentioned earlier will bring with them increased revenues which will assist us to retain our policy of setting taxes which are affordable to both our residential and business taxpayers, while providing amenities designed and built to serve City residents. We have also joined a national study, with the Community University Research Alliance, of participatory budgeting at the community level to see what enhancements in participation we can offer to residents during our annual budget process.

As promised in 2002, Surveys were conducted in the City's ongoing efforts to involve its citizens in our financial planning processes. These survey results are invaluable to Council in providing guidance for development of the City's operating and capital plans. We continue to want to hear from City residents about what exciting projects they think are important, the services we provide, their satisfaction with our service delivery, tax levels and other top of mind issues they may have.

In June Council adopted the new Corporate Strategic Plan. The City's Strategic Plan will deliver the necessary focus on projects and priorities to give life to the City's goal of becoming a more sustainable community. The Strategic Plan recognizes that the state of the organization is critical to be able to serve the community. Therefore, focus is placed on our staff under the heading **'Innovation and Learning'** and on how services are delivered under the heading **'Internal Functioning.'** These, in combination with a focus on **'Community'** and **'Finance'** are intended to provide a tool through which resources and attention are focused on what is most important.

In this period of major development in the City, it is critical that we are able to bring our collective energies together on those issues. The City now moves from the creation and design phase, to the next phase of the Strategic Planimplementation.

- Option No. 1 – places the library in the North West quadrant of the block and represents two 66 metre (24 storeys) towers plus a low rise building (4 storeys) in between.
- Option No. 2 – places the library in the North East quadrant of the block extending into the 14th Street Plaza by approximately 30 feet. The North Tower is represented as 66 metres (24 storeys) and the South Tower is 50 metres (18 storeys). The balance of the floor area is contained in low and mid-rise buildings (4 - 7 storeys).
- Option No. 3 – places the library in the North East quadrant of the block but maintains its northern face approximately in line with the City Hall building. The residential floor space is represented in two 55 metre towers (20 storeys) with the balance in two mid-rise (7 storeys) and one low-rise (4 storey) buildings.
